### Reason for Transfer

Why has the RCCP become a wholly owned subsidiary of AHCS? We are excited to work together in the interests of patient safety, public confidence and provide clarity for professionals, the profession, employers and educators.

### Background Information

What does the Academy for Health Care Science (AHCS) do? The AHCS is the overarching body for the whole of the Healthcare Science professions.

The AHCS maintains a PSA accredited register of a range of healthcare science disciplines including clinical physiologists. It also maintains directories designed for groups who are at an early stage of the journey towards registration. It works with the National School for Healthcare Science (NSHCS) to accredit education and training programmes. Like the RCCP, it sets standards and holds its registrants accountable to its standards through its Continuing Professional Development (CPD) requirements and its Fitness to Practise process.

The AHCS is approved by the Health and Care Professions Council (HCPC) as an education provider for the STP equivalence route. The successful completion of this route provides an individual with eligibility to apply for HCPC registration as a clinical scientist.

**How will this affect me?** The transfer will improve public safety by maintaining and strengthening the contribution registration makes to ensuring public safety.

# What will happen next?

A newly structured RCCP Board will operate alongside the existing board of the AHCS. This Board will retain all RCCP Directors with the exception of the retiring Chair of the RCCP - Paul Burgess MBE. New AHCS Directors will be added and the AHCS Chair John Stevens will Chair this newly constructed Board.

The new RCCP Board will over the period 2<sup>nd</sup> June 2021 to 31<sup>st</sup> March 2022 carry out a strategic review of all activities as it looks to bring all RCCP and AHCS activities together and its looks to the future in terms of development opportunities. It will also consult with the Advisory Council on the views of the Professional Bodies as it moves forward.
